SEC. 32.36 MEETINGS.

(A) The City Council shall meet for its regular Council meeting on the second Monday of each month, beginning at 7:00 p.m., prevailing time, at a facility located in Park Hills, Kentucky. However, in the event the second Monday shall fall on a recognized national or state holiday then its regular Council meeting shall instead take place on the Tuesday immediately following at 7:00 p.m., prevailing time, at the same location. Notice thereof shall be timely provided by the City Clerk.
